- (c) Internet Broadband connection with good speed on continuous basis



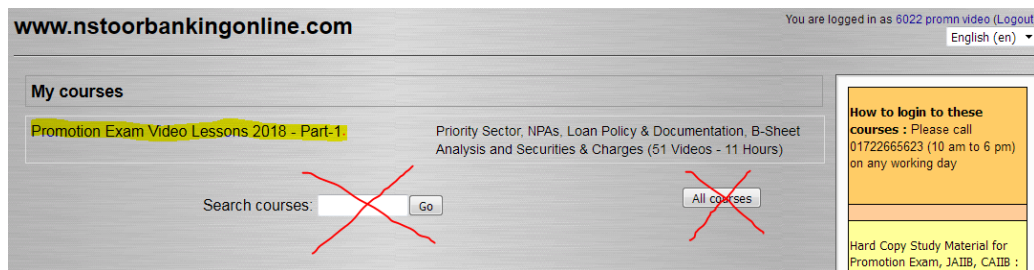

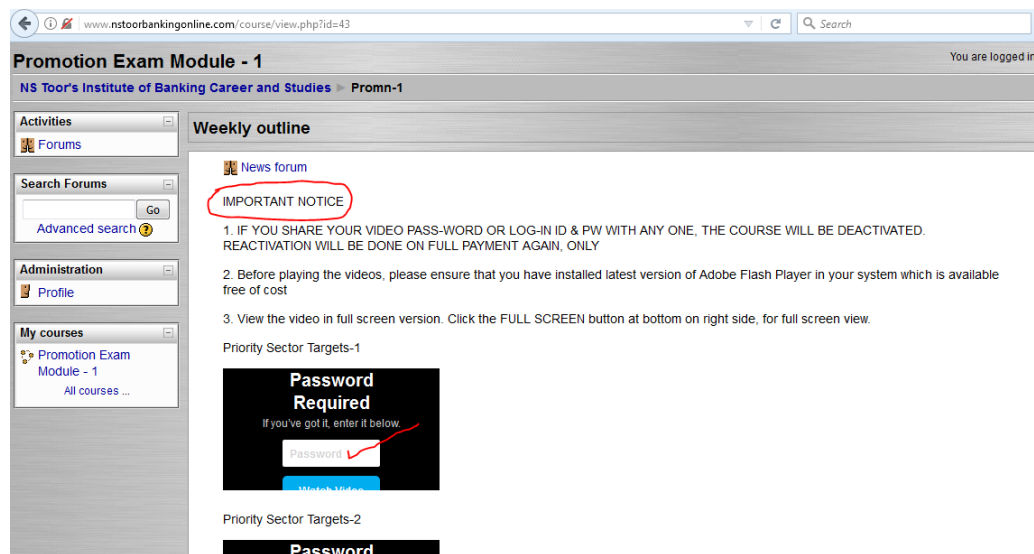
